

CHICKASAW POINT GOLF COURSE MEMBERSHIP INFORMATION – PUBLIC MEMBERS

Thank you for considering membership at Chickasaw Point Golf Course. Below is a list of membership benefits. Membership options and cost information can be found in this packet. Please feel free to contact the Pro Shop staff at 864-972-9623 if you have any questions. We look forward to seeing you often!

Golf Course Club Membership Benefits:

- Annual dues and trail fees may be auto-paid quarterly by credit card. However, a \$25 per quarter administrative fee will be added. Weekday and Weekend memberships are available for members who play less often.
- Tee time reservations are allowed up to two weeks in advance.
- Members can choose to use either a Club Cart or their own personal cart. The fees for each option are detailed on the attached price sheet.
- Private cart storage is available on a limited basis for \$20/month.
- Members who lose use of their personal cart for a **short period of time**, i.e. maintenance, in use by another family member, may use a club cart at no cost. The Club cart cannot be taken off of Golf Course Property, such as taking it home.
- Members may walk the course free of charge after reserving a tee time and checking in with the ProShop staff.
- State-of-the-art GHIN handicap services provided for \$27 per year.
- Members receive a 20% discount on all Pro Shop merchandise.
- Members may invite non-member guests to join them to play for the posted Member Guest rate.
- Participation in member-only events and various golf leagues is available. Additional Tournament Fees may be required.
- Driving Range membership is available for members.

MATTERS OF IMPORTANCE

Agreement

1. Upon execution of this agreement and payment of all required fees, the member(s) shall be entitled to play unlimited golf, excluding tournaments without additional payment of green fees.
2. Membership is an annual commitment. Cancellation of membership by the member requires a thirty (30) day written notice mailed or hand delivered to the CPGA, Inc. General Manager. It will be required to pay the initiation fee to rejoin once a membership has been cancelled.
3. If Range Membership is selected, Member(s) will abide by policies set forth in the Range Membership Agreement.
4. It is understood that payment of Membership Dues does not give a non-resident member any rights of ownership in Chickasaw Point Golf Course or its facilities.
5. The Member understands that CPGA, Inc. is operated as a public golf course and the rights granted herein does not limit CPGA, Inc.'s right to offer play or use of the course facilities to the general public.
6. CPGA, Inc. reserves the right to change/revise all costs, fees, prices, services and operating hours at their own discretion.
7. Member hereby agrees to indemnify and hold CPGA, Inc., employees, directors, shareholders, officers, and other members, harmless from any and all loss, claim, injury, damage or liability which may be incurred as a result of the use of CPGA, Inc.'s facilities and club carts, by Member, Member's family and guests.

Privileges

1. TEE TIMES: Members shall be permitted to reserve tee times up to fourteen (14) days in advance on a first call, first reserved basis. Events, outings, and tournaments will be scheduled and posted not less than thirty (30) days prior to the event if possible. Members may be invited to participate in events at the discretion of CPGA, Inc.
2. MEMBER GUESTS: Members may use the preferred reservation system to schedule tee times for the Member and up to three (3) guests, provided the Member plays with his/her guests at the reserved time.
3. GOLF CARTS: Members will be allowed to use private carts with a payment of the appropriate trail fees at any time. Club carts will be available on a first come first served basis for use with payment of member cart fees.

Termination of Membership

The Membership may be suspended or terminated by CPGA, Inc. for any of the following reasons:

- a. Commission of any theft at the facilities.
- b. Willful destruction of CPGA, Inc. property, or property of other Members, their family or guests.
- c. Physical or verbal abuse of staff or other Members, their family or guests.
- d. Breach of this annual Membership Agreement or violation of the Membership Policies, including refusing to comply with the club's dress code.
- e. Sufficient cause as determined by CPGA, Inc. in the best interest of the club.

In the event of any of the above violations, CPGA, Inc. may give the Member written notice of possible termination. The Member has a period of ten (10) days from receipt of notice to respond in writing. Within thirty (30) days of any response received, CPGA, Inc. will make final determination whether the Membership should be terminated and shall notify the Member in writing. CPGA, Inc. shall have the right to suspend membership privileges of Member pending final decision upon the violation. In the event of termination of Member, Member will be liable for all fees and charges incurred with CPGA, Inc. through the effective date of termination and no refund or any part of the of Annual Membership fees will be made.
